

Right to Information Manuals

(17 items(manuals) prescribed in clause (b) sub-section 1 of Section 4 which every public authority is required to publish within one hundred and twenty days from the enactment of this Act)

(i) the particulars of its organisation, functions and duties;

(ii) the powers and duties of its officers and employees;

Consul General supervises the functioning of the Consulate, which is distributed between three Wings - Consular; Administrative; and Commercial. All decisions are taken under the instructions and supervision of Consul General.

(iv) the norms set by it for the discharge of its functions;

Consulate endeavours to provide all consular services within the timeframes provided on the website of Consulate General of India Melbourne.

(v) the rules, regulations, instructions, manuals and records, held by it or under its control or used by its employees for discharging its functions;

(vi) a statement of the categories of documents that are held by it or under its control;

Same as Ministry of External Affairs, Government of India, but only as applicable to the consular jurisdiction of Victoria and Tasmania.

(vii) the particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof;

(viii) a statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public;

Consulate General of India interacts regularly with representatives of think tanks, academic community, and others.
